### Declaration of Adoption

This document has been reviewed by the Senior Leadership Team and has been formally adopted.

From 1 July 2015 all schools are subject to a duty under section 26 of the Counterterrorism and Security Act 2015, in the exercise of their functions, to have “due regard to the need to prevent people from being drawn into terrorism”. This duty is known as the *Prevent Duty for Schools*. We recognise our responsibilities and take a number of steps to ensure we meet the demands of this duty.

At Windale Primary School, we build pupils’ resilience to radicalisation by promoting fundamental British Values and enabling our pupils to challenge extremist views.

Our schools’ ethos and safeguarding work is set in the context of the Family Links Nurturing programme which builds emotional health and resilience, helping children to recognise the pressures that they may face and strengthening their capacity to challenge peer pressure and to act with integrity.

The children follow a ten-week programme that repeats in a spiral curriculum, three times a year every year throughout their time with us. The programme is delivered through a weekly circle time – but each class can add in more circle times if issues arise, that they want to explore further.

The statutory guidance refers to the importance of *Prevent* awareness training to equip staff to identify children at risk of being drawn into terrorism and to challenge extremist ideas. All of our staff have received Prevent duty training on what *Prevent* is about and how to deal with any issues they may see inside or outside school. All staff are trained in the PREVENT duty on appointment, with regular updates as part of their in-service professional development.
